THE PROGRAM IS PRIMARILY AIMED AT SUPPORTING THE WOMEN JUDGES IN THEIR DAILY WORK IN THE COURTS, ENCOURAGING THE APPOINTMENT AND PROMOTION OF WOMEN JUDGES THROUGHOUT ALL LEVELS OF THE JUDICIARY AND PROVIDING NETWORKING AND JUDICIAL EDUCATION OPPORTUNITIES FOR THE WOMEN JUDGES, BOTH IN AFGHANISTAN AND IN THEIR PARTICIPATION IN INTERNATIONAL JUDICIAL PROGRAMS.

4b (Code:) (Expenses \$ 172,263. including grants of \$) (Revenue \$) IN HAITI, THE IAWJ HAS CULTIVATED CRITICAL LEADERSHIP IN THE JUDICIAL SECTOR WHICH WAS AMONG THE MULTITUDE OF VICTIMS TO THE CATASTROPHIC EARTHQUAKE OF 2010. THE IAWJ ADDRESSED THE NEED FOR SUPPORT PERSONNEL AND TRAINING OF HAITIAN JUDGES BY PARTNERING UP WITH ITS LOCAL ASSOCIATION AND ASSEMBLING KEY LOCAL STAKEHOLDERS TO LAUNCH A COMPREHENSIVE TRAINING PROGRAM ON HUMAN TRAFFICKING. THE RESULT OF THESE EFFORTS WAS A CUSTOM-TAILORED "TRAIN-THE-TRAINERS" (3TS) SEMINAR WHICH HAS ALREADY TRAINED 28 LOCAL JUDGES AND MAGISTRATES WHO ARE NOW QUALIFIED FACILITATORS AND CAN TRAIN THEIR COLLEAGUES ON HUMAN TRAFFICKING.

THE FOCUS OF THE PROGRAM IS ON IMPROVING THE JUSTICE SYSTEM'S RESPONSE TO ISSUES OF SEXUAL VIOLENCE. IT SEEKS TO DISTILL SOME OF THE LESSONS LEARNED IN INTERNATIONAL TRIBUNALS AND MAKE THEIR WISDOM AND EXPERIENCE MORE WIDELY AVAILABLE TO JUDGES AND OTHER SELECTED END USERS IN THE TARGETED COUNTRIES. IN ADDITION, THE STORY OF WOMEN JUDGES' LEADERSHIP ROLES ON THE INTERNATIONAL TRIBUNALS IS IN DANGER OF BEING LOST. THIS PROJECT SEEKS TO PRESERVE THE HISTORICAL RECORD THROUGH INTERVIEWS WITH INTERNATIONAL WOMEN JUDGES AND BY CREATING WEB-BASED AND VIDEO MATERIALS DOCUMENTING THEIR LEADERSHIP.
